



PARTICIPANT RELEASE SHAOLIN

PLEASE READ CAREFULLY

For purposes of this “Participant Release” document, “Event” means any Shaolin Wellbeing workout that I may attend now or in the future, at any location, any and all transportation to, from and between any Shaolin Wellbeing workout locations, all product testing at any Shaolin Wellbeing workout, and all other activities related to any Shaolin Wellbeing workout and to my participation in any Shaolin Wellbeing workout. In consideration of the opportunity to participate in the Event, (the receipt and sufficiency of which is hereby acknowledged), I hereby irrevocably and unconditionally for myself, my heirs, estate, insurers, successors and assigns, agree as follows:

ASSUMPTION OF RISK: SHAOLIN WELLBEING LTD has made no representation to me as to the suitability, condition, or safety of the Event venue and I acknowledge that participation in the Event may involve risks and dangers of accidents, personal and bodily injury and property loss or damage. I confirm that I am in good health and have no medical or health condition that could endanger or limit my ability whilst participating in the Event. I understand and have considered and evaluated the nature, scope and extent of the risks involved, and I voluntarily and freely choose to assume these risks. In addition, I agree to comply with the reasonable instructions of the Event leaders during the course of the Event.

INSURANCE: I understand that SHAOLIN WELLBEING LTD does not provide any insurance, whether life or medical or liability, for any illness, accident, injury, loss or damage that may arise in connection with my participation in the Event.

INDEMNITY: To the maximum extent permitted by applicable law, I hereby irrevocably and unconditionally agree to hold harmless, indemnify and reimburse S SHAOLIN WELLBEING LTD from and against any claim, sum, costs, damages or expenses (including reasonable legal fees) arising in connection with any accident, loss or damage arising out of my attendance or participation in the Event.

REFUND: At least 72 hours notice is required for the cancellation of any bookings made for private lessons, talks or presentations. Failure to do so will result in the booking fee forfeited. Refunds are available at the discretion of the Shaolin Temple Cheshunt. Tuition Fee for all classes must be paid by the last day of each term. Any payments received after the last day of term will encounter an additional £10 charge for admin and will be charged the new rate for the following term. We will begin to take payments for the following term during week 8 of each current term. TRIAL- Once a payment for a trial session has been paid and the Trial session has not been canceled at least 72 hours in advanced no refund will be available. MEMBERSHIP - Once payment for membership has been made there is a strict no refund policy in place. Membership includes a free uniform which will be received on payment for the term. TERM | HALF TERM - Term and half term payments are non refundable once the first session of the current term has commenced regardless if the student attends or not. Term payments allow the student to begin training from week 1. Half term payments allow a student to begin training from week 6. PAY AS YOU GO - Payments made for any classes are non refundable once the classes have begun. Membership will be closed if tuition is not paid for by week 2 of the following term.

NON TRANSFERABLE: I understand that my participation in the Event is non-transferable and is not redeemable for cash.

VALIDITY: If any clause in this agreement is held, in part or in full, to be invalid or unenforceable for any reason, the validity of the remaining clauses of this agreement shall not be affected, and they shall continue to be valid and enforceable. The invalid or unenforceable provision shall be replaced with a valid provision which is as similar as possible in substance to the invalid or unenforceable provision. This form supersedes any oral or written agreement made previously in relation to the Event.

JURISDICTION AND INTERPRETATION: This Agreement shall be construed and interpreted in accordance with English law and shall be subject to the exclusive jurisdiction of the competent courts of England.
